### How we store your personal information

Your information is securely stored.

We keep your name, contact details (address, email address, telephone number) for as long as it is reasonably required to complete the task in relation with which it was collected. We will then dispose your information by deleting the relevant data files and destroying any printed/hard copies.

#### Your data protection rights

Under data protection law, you have rights including:

**Your right of access** - You have the right to ask us for copies of your personal information.
